Ethics Reading List With a Speciality in Metaethics

The purpose of this list is to inform a graduate student contemplating focusing on metaethics as a major or minor area for his or her comprehensive examinations of some basic reading relevant to the subject. A student may use this information for one or more of two purposes: To decide whether to take a comprehensive exam in this area, and if so, to get started early on reading central texts in preparation for a comprehensive exam in this area. Item C below explains the options students have in filling out their reading list.

The core readings for the *major exam* in metaethics are organized into **A.** Historical Sources & Perspectives and **B.** Metaethical Theories. Core readings for the *minor exam* in this area include the readings under **A** plus the starred readings in **B**. Instructions for filling out the reading list with select readings is explained below under **C**. Topics in Metaethics.

Students who wish to take either a major or a minor exam in this area are strongly encouraged to contact one or more members of the area committee for advice about the area's readings and exam.
